Bid Envelope:

All prospective Bidders are to be Licensed Contractors in the State of South Carolina in accordance with the South Carolina Code of Laws (Unannotated). Refer to TITLE 40 – Professions and Occupations, CHAPTER 11. CONTRACTORS. See www.scstatehouse.net/code for the Code of Laws. It is the responsibility of the Bidder to comply with the applicable Codes. No bid will be opened unless the outside of the sealed envelope containing the bid provides the following information: the contractor's name, license number, the date of the licenses expiration, and a quotation of that part of his classification applying to the bid

FOR ALL CONTRACTS THAT EXCEED \$250,000

Each prime bidder must deposit with his bid security in the amount of 5 percent of the bid. Bid Bonds and Performance and Payment Bonds must be secured by a guaranty or a surety company listed in the latest issue of U.S. Treasury Circular 570 and shall be within the maximum amount specified for such company in said Circular 570. The "Bid Bond" and the "Performance and Payment Bond" must be issued by a surety company authorized to do business in the state where the project is located and must be listed in U.S. Treasury Circular No. 570.

The right is reserved to reject any or all bids or to waive any informalities in the bidding. No bidder may withdraw his bid within 60 days after the actual date of the opening thereof.
