

Child Care Vouchers for Essential Employees

As part of the CARES Act (Coronavirus Aid, Relief and Economic Security) funding, DSS is offering child care assistance for parents that work in businesses that have been deemed essential based on Governor McMasters Executive Orders. In order to qualify, you must be currently working at an essential business, you must need child care so you may continue to work, and you must complete a child care application. You do not have to meet any income guidelines for this limited program.

If would like to apply and feel you meet the criteria, please email Christi Jeffcoat at christi.jeffcoat@dss.sc.gov. In the email, you will need to indicated your first and last name, the best phone number to reach you and the occupation/business where you work. In the subject line, please put "Essential Employee Child Care Request". Upon receipt of your email, staff will coordinate with you by sending you the child care application and any other information that may help you find child care.
