### COVID-19 Vaccine

From the S.C. Department of Health and Environmental Control

Our top priority is to save lives. Everyone will have a chance to get the vaccine. However, the number of doses is currently limited in South Carolina like in all states. We ask everyone to please be patient, learn what phase you're in and follow the guidance of our public health officials.

Phase 1a—Healthcare Workers & 70+ (Current/Ongoing) Phase 1b—Essential Frontline Workers (Late Winter 2021) Phase 1c-65+, 16+ at high risk, Essential workers (Early Spring 2021) Phase 2—Available to all people (Expected late Spring 2021)
